# 3. Guests and Deputations-

Todd Lucier addressed Council to discuss the idea of an outdoor Ice Ribbon around Tom Thomson for the public. Mr. Lucier provided Council with a detailed proposal on the concept, the time involved and what equipment and upkeep would be necessary. He also listed potential hurdles which would need to be researched and discussed prior to a firm decision being made. The Ice Ribbon could attract more visitors to the village and surrounding area during the winter month. Janet Baynton and Jim Stephenson addressed Council to provide an update on the 2018 South River Machar Agricultural Society's Fall Fair. Council was advised the Society would not require the ice to be covered for the fair but they would require the upstairs hall, the outside pavilion and the remaining arena grounds. It was hoped, as a fund-raiser, the Spartan's would consider either a "Skate with the Spartan's" or a home game and the Agricultural Society would be serving a dinner upstairs.

Council was also advised of the serious financial situation the Agricultural Society would be facing this year. Costs to put on the fair continue to rise and insurance is a very large ticket item. Janet asked if the Village would consider placing the Agricultural Society on the Village's insurance as a rider. The Ag Society understands some other small fairs in the area have had municipalities make such an addition to its insurance.

Council will investigate this possible solution and get back to Janet.

The meeting was very positive and optimist. Council extended best wishes to the Agricultural Society as it moves forward with the planning for the fair.
