3. Re-Zoning Application Approval for 19 Hunter Street:

Public in Attendance was Brian Edward and William Van Klaveren. Mr. Edward spoke about 19 Hunter as a previous owner of the building and current neighbor to this property. He is looking forward to the upgrades as the building has been neglected the past few years. Mr. Edward was wondering what Councils intent was by changing Ottawa Ave to C1 mixed when this zoning changed years ago. Councillor Scott explained that the downtown business core section is now along the Highway 124 corridor as there are not many businesses remaining on Ottawa Ave and changing the zoning to C1 allowed for residential spaces. Property owners can now ask to have their zoning changed to residential to allow for residential units. Mr. Edward and Mr. Van Klaveren are concerned that by changing the zoning it may reflect in the value of their properties should they decide to sell in the future. As well the impact of the change would result in less taxation as residential tax rates are lower than commercial. Their other concern was that there may not be an adequate amount of parking spaces as there are usually 4-5 vehicles parked there daily. In Conclusion Mr, Edward and Mr. VanKlaveren would prefer that it stay zoned as commercial. Mr Edward and Mr. VanKlaveren left the meeting at 5:53pm.
