8. Council Roundtable

Councilor Scott raised the subject of garbage being inappropriately left at Tom Thomson Park. Possible causes, including the closure of dumps in adjoining unorganized townships, were discussed. Possible avenues of investigation and remedies were considered.

Principal areas of concern were the cost and the burden to municipalities and a desire for training for new councilors.
