<u>Village of South River</u> Council Meeting – December 12, 2022

The meeting of the Council of the Village of South River was held virtually and in person on Monday December 12th, 2022. A quorum was present. 1. Call to Order as the Council of the Village of South River and Swearing In

- The Meeting was called to order by Mayor Jim Coleman at 5:32 PM

3. Delegation and Public Meeting

1. Micah Streeter – 2023 Black Fly Festival

Regarding Item 3.1 Micah Streeter – 2023 Black Fly Festival: Black Fly Festival Representative, Micah Streeter, encourages the restoration of the famed Black Fly Festival that was previously held in South River prior to the Covid-19 Pandemic. Streeter explains that the core festival is proposed to take place over the course of two days dated for the May long weekend in 2023, including pro and amateur tournaments, disc golf vendors and community involvement. The 80 player tournaments will take place on the Tom Thomson Park disc golf course, as the course is recognized for the ability to hold competitors and spectators alike. The festival is being proposed as a way to help grow the awareness of disc golf in the area in addition to influence community involvement and increased economic growth for the community, as local businesses will be encouraged to participate. Streeter requests that the Village supports the event and provides essential facilities for the event, this includes; portable washrooms, maintenance of the disc golf course, extra garbage cans, use social media platforms to share promotional material and most importantly support from Council and the Village to continue with the development of the festival. Council noted that their support for the event and that the South River Sportsman Show took place on the May long weekend last year. If it should take place again on the same weekend both events would benefit from the added visitors. Council stated that they welcome the event and are excited to see more organizations utilizing Tom Thomson Park.

Discussion of Item 5.1.1 November 2022 Income Statement Council referenced the need to see the correlation of the current year and pervious years statements side by side for comparison value. Council anticipates that the new accounting program Townsuite will provide this information in a practical format. Council recommends that the bank reconciliation be revisited once the transition to Townsuite software is completed.

During Discussion of Item 5.1.4 2023 Draft Water Rates Council highlighted how comparable municipalities operate the water billing rates and the structure that is utilized. Council discussed the contrasting water service charge formats that have been used for pervious billing; concluding that current meter by consumption configuration is the format that best suits the Village appropriately. The billing system effectively shares the base load for delivery and fire protection while also discouraging waste by charging an escalating amount for consumption.
