<u>Village of South River</u> Council Meeting – October 11th, 2022

The meeting of the Council of the Village of South River was held virtually and in person on Tuesday October 11th, 2022. A quorum was present. 1. Call to Order – The Meeting was called to order by Mayor Jim Coleman at 5:33pm

2. Declaration of Pecuniary Interest and General Nature Thereof -Nil

3. Delegation and Public Meeting

3.1 Public Meeting – Regulate the Keeping of Poultry By-law

The discussion in public meeting in regards to the Regulate the Keeping of Poultry Draft By-law called attention to residents' concerns, comments and questions regarding the subject.

Mihajlo Spasic Spoke Regarding the Following:

Mihajlo Spasic states that the keeping of a rooster is necessary to provide longevity and superior egg quality to help provide for a family. Mihajlo agrees with the standards for the keeping of hens proposed in the By-law.

Haley Riebeth Spoke Regarding the Following:

Haley Riebeth expressed concerns regarding the number hens allowed on one property and suggests the number should be increased to 10-12 chickens. In addition, the proposed setbacks from the property line were discussed and the amount of square footage required per hen was suggested to decrease from 4 to 2 square foot per hen.

Martha Jacobs Spoke Regarding the Following:

Martha Jacobs expressed concerning regarding the conditions of coops resulting in flies and harsh odor from substandard ownership.

Tim Hainsworth Spoke Regarding the Following:

Tim Hainworth noted that commercial businesses need to uphold particular food safety standards and the excessive amount of poultry or unsanitary conditions could jeopardize this for businesses.

Council highlights the necessity of establishing guidelines for keeping poultry in The Village of South River and the importance of public input in such matters. Council understands that the standards for keeping hens fall under the appropriate guidelines for animal welfare accordance to the provincial law. Council will take into account the matters discussed in the public meeting and note that further discussion is needed to proceed with the finalization of the proposed By-law and input sought from Municipal Law Enforcement Officer.

3.2 J.Busch Women's Own Resource Community Kitchen and Festival

Jessica Busch, Program Manager with the Women's Own Resource presented opportunities of community involvement in regards to creating a quarterly Community Kitchen event in the North, Central and South areas of the Almaguin Highlands beginning in 2023. Jessica Busch suggests that the Village of South River be the central point of the Community Kitchen Program and hopes that Council will draft a letter of support for the application towards preparation and funding of the event. Council agrees that the event will be an immense benefit for the community and supports in principle the Community Kitchen at the South River Machar Community Centre. In addition to the Community Kitchen, Jessica Busch proposed an annual festival be established in the Village of South River with Tom Thomson Park being a candidate for a prime location. The festival is proposed to include vendor markets, food trucks, bouncy castles, local musicians, and a headlining concert scheduled for the end of the night. The suggestion is to ensure that the festival becomes an annual event that highlights the businesses and spirit of the Village of South River for years to come. Council acknowledges that there will be a need for additional planning to create the event and agreed to support the event in principle.
